KOSSE TEXAS FARMERS MARKET

2013 Rules & Guidelines

1. Market Overview:

- a. The KFM (Kosse Farmers Market) hours of operation shall be Saturdays from 8am-12 from May 18th to October 20. The market is located downtown Kosse on Main Street (Narcissus).
- b. The market exists to:
 - Create a sense of community and unity for people in and outside our city limits.
 - Promote local businesses and create economic development around foods that are grown, raised, and processed locally.
 - Raise awareness about the rich and diverse agricultural area in Kosse.
- **c.** The markets definition of local in within the city limits of Kosse, and to reach out of the city limits up to 8 miles.
- d. No franchises are allowed to sell at the Market.
- e. Booth fees are as follows: \$10 per table per Saturday/with a annual fee of \$35 for producers who have a Kosse address, and \$45 for out of range producers. If you have more than one table the fee may be waived for a period of time as delegated by the board as a effort to promote our newly formed Kosse Farmers Market.
- **f.** Booths are assigned based on diversity of product or at market manager's discretion.
- **g.** All vendors must have membership on file by May 1st.
- **h**. No smoking will be allowed by vendors while managing their produce. (or you must step away 50')

2. Information for all vendors:

- **a.** Vendors may have one booth. Exceptions may be made by the market board members.
- **b**. Vendors must display a sign identifying the name and location of the business
- **c**. Prices must be placed visible to the consumers
- **d.** Vendors must leave street frontage available for consumers (you must unload your produce prior to 8am) parking.

3.Fruits & Vegetables:

- a. 75% or more of all produce offered for sale must be homegrown. Presale of a local growers produce is allowed provided that the vendor is knowledgeable about the growing practice of that farm on which that produce was grown. Produce resold in this manner must be labeled with the farm name or location where it was sourced.
- c. No brokered or wholesale products are permitted.
- d. The term "organic" may only be used by farms that are certified organic. Vendor must display their certificate at the market.

4. Meats & Poultry

- a. All meats and poultry to be sold at the market must be owned and raised by the farmer selling them. Selling meats from other farms is prohibited.
- b. All meats and poultry to be sold at the marker must meet Federal, State and local preparation, licensing, labeling and storage regulations.

- b. All meats must be processed in a USDA inspected slaughter facility.
- c. Small poultry producers may have their birds processed either at a USDA inspected plant or an MDARD inspected plant. If the product originates at an MDARD-inspected facility, it is necessary to have a copy of the MDARD license on hand at the farmers market. Poultry from farms raising more than 20,000 must also be processed as such. A USDA seal of inspection must appear on all packages of meat originating from that plant.

5. Eggs:

a. All eggs to be sold at the market must come from flocks owned and raised by the farmer selling them. Selling Eggs from other farms is prohibited. All eggs to be sold at the marker must meet Federal, State and local preparation, licensing, labeling and storage regulations, which require personal labels, and a 45 degree or cooler climate.

6. Fish:

a. All fish must meet the Federal, State and local preparation, licensing, labeling, and storage regulations.

7. Dairy Products:

a. All dairy products including cheese, yogurt, cream etc.to be sold at the market must meet Federal, State and Local Preparation, licensing, labeling and storage regulations.

8. Baked Goods

- a. All baked goods must be prepared using as many local ingredients as possible
- b. All vendors selling bake goods will display a sign with each locally-soured ingredient listed, along with the farm oar business from where it was sourced.
- c. All baked goods must be prepared in a licensed kitchen unless such items meet the criteria identified in the Cottage Food Law.
 - Must be non-potentially hazardous that do not require time and or temperature control for safety as defined under the law
 - It must be approved by the market manager
 - It must be properly packaged and labeled with all information specified by the law

9. Prepared Foods

a. All prepared ready to eat foods to be sold at the marker must meet Federal, State and local preparation, licensing and storage regulations.

10. Plants:

a. All potted plants, herbs. bedding plants, nursery stock or cut flowers sold at the marker must be grown by the vendor selling them. No wholesale or brokered products will be allowed.

11.Arts & Crafts:

a. Food and Garden products are desired over arts and crafts it is at the discretion of the board to limit how many arts and crafts may be sold. If allowed arts and crafts must be made by the vendor.

12. Liability Insurance

- a. Kosse Farmers Market assumes no responsibility and shall not be liable for any damage or injury.
- b. Kosse Farmers Market requires that vendors either:
 - Name the KFM as additional insurance on their farm/business liability insurance policy and proved proof of the coverage or
 - Sign a "hold harmless" agreement

- FAILURE TO ADHERE TO ANY OF THE ABOVE RULES MAY RESULT IN FORFEITURE OF YOUR SPACE OR TABLE. THE MARKET WILL OPERATE BY A

"THREE STRIKES" POLICY, WEHRE BY

- 1) THE FIRST VIOLATION WILL RESULT IN A VERBAL WARNING
- 2) THE SECOND VIOLATION WILL RESULT IN A WRITTEN WARNING
- 3) THE THIRD VIOLATION WILL RESULT IN SUSPENSION OF MARKET PRIVILEGES FOR AN AMOUNT OF TIME TO BE DETERMINED BY THE MARKET BOARD OF DIRECTORS.
